## INTRODUCTION

### 1.1. Background

The Workflow Management Coalition is a non profit organisation with the objectives of advancing the opportunities for the exploitation of workflow technology through the development of common terminology and standards.

Within the WFM Coalition organisation, the Technical Committee is responsible for the development of appropriate technical specifications and related documents, which are approved for formal issue by the WfMC Steering Committee.

To achieve this objective the Technical Committee has established a number of Working Groups responsible for different aspects of its standardisation programme. Technical specifications are developed by these individual Working Groups, working within the overall framework of the WfMC Reference Model and following agreed common architectural principals.

Such specifications typically proceed through a series of stages:

- White Paper (discussion document)
- Internal Working Drafts
- Draft specification for controlled external use (Beta version)
- Full specification for general public release

### 1.2. Purpose

This document provides the index to the formal TC documentation set, covering documents in existence or under production which have been allocated a formal TC document identifier.

### 1.3. Scope

This document covers only the formal TC documentation. It does not cover ad hoc documents or working papers developed internal to the working groups.

This document indicates the current document version, status and current document editor or author for superceded documents.
